TERMS & CONDITIONS

1. ALL TAXI RATES ARE METERED AND REGULATED BY THE CITY OF LONDON. THEY ARE NON-NEGOTIABLE. RATES ARE BASED ON KILOMETERS AND TIME. FARES MAY VARY DEPENDING ON TRAFFIC CONDITIONS AND THE ROUTE TAKEN.
2. GREEN TAXI IS NOT RESPONSIBLE FOR THE MONITORING OF PROPER AUTHORIZATION FOR ANYONE WHO PLACES A CALL FOR TAXICAB SERVICE FROM GREEN TAXI ON A CHARGE ACCOUNT WITH A VALID ACCOUNT NUMBER. ALL CHARGES MADE BY ANYONE WITH A VALID ACCOUNT NUMBER WILL BE THE RESPONSIBILITY OF THE ACCOUNT HOLDER. FOR YOUR PROTECTION, ACCOUNT NUMBERS SHOULD ONLY BE GIVEN TO AUTHORIZED INDIVIDUALS. ONLY THE ACCOUNT HOLDER OR AUTHORIZED INDIVIDUAL SHOULD MAKE THE CALL FOR TAXICAB SERVICE.
3. GREEN TAXI IS NOT RESPONSIBLE FOR MONITORING THE PASSENGER'S DESTINATION. ANY STOPS MADE ON THE WAY TO THE FINAL DESTINATION ARE SUBJECT TO WAITING TIME CHARGES. THESE FEES ARE THE RESPONSIBILITY OF THE ACCOUNT HOLDER.
4. BY SIGNING THIS AGREEMENT THE ACCOUNT HOLDER AND CREDIT CARD HOLDER AUTHORIZE GREEN TAXI TO AUTOMATICALLY BILL THE CREDIT CARD NOTED ON THIS APPLICATION FOR ALL CHARGES INCURRED ON THIS ACCOUNT. A STATEMENT DETAILING ALL CHARGES TO THE ACCOUNT WILL BE ISSUED UPON REQUEST.
5. ACCOUNTS ARE BILLED APPROXIMATELY BY THE 5th BUSINESS DAY OF EACH MONTH, AND ARE DUE AND PAYABLE UPON RECEIPT.
6. AN ACCOUNT UNPAID BY THE END OF THE MONTH WILL BE SUBJECT TO A LATE PENALTY OF 2% PER MONTH.
7. THE ACCOUNT CAN ONLY BE CLOSED WHEN THE CLIENT RETURNS ALL UNUSED CHITS AND VOUCHERS.
